

Please read the following IndependentPet Consultant Agreement and Policies

After reading the agreement, if you agree to accept and abide by the terms and guidelines set forth, you may complete the Agreement form and send or fax Botanical Dog to complete the enrollment process.

1. You must be 18 years of age or older to become a Botanical Dog Consultant.
2. You understand that you are not employed by Botanical Dog. You are an IndependentPet Consultant and you are the Owner of your own business. The exception being when sales are made thru your web page link the profit from sales is considered commission.
(As quoted in IRS Publication 911) If some of your customers buy their products directly from the company website thru your web page link you, as the sales agent, do not have any sales income from these transactions. You will receive a commission for making the sale, but you will have no direct income from the sale itself. Report your commissions as other business income.
3. It is your responsibility to obtain any and all necessary business licenses and tax forms required to operate a business. (Contact your local and state government for requirements. See IRS Pub 911-Direct Sellers.) Including the necessary sales tax license
Botanical Dog pays sales tax on sales generated thru your web page. All other sales you must charge sales tax for and submit a sales tax return
4. As an IndependentPet Consultant and Owner of your business, you are responsible for keeping records of your income for tax purposes. Botanical Dog will provide a record of your sales and commissions to you at the end of every year.
5. There are no monthly minimum orders to meet, to maintain your Pet Consultant status. However, if for 3 months there is no contact by phone, email, or mail by you, your account will become inactive. After 6 months of inactivity, you will be no longer considered a Botanical Dog IndependentPet Consultant and will no longer be eligible for Discounts or other incentives.
6. Shipping rates apply to all orders. There are no discounts on shipping.
7. By agreeing to become an IndependentPet Consultant of Botanical Dog you have given your permission to receive updates on products, pricing, or any changes that will affect you as a Pet Consultant. These updates will be sent via Email or Mail.
8. We do not make claims or guarantee your financial success by becoming a Botanical Dog Pet Consultant. Your success depends on the sales and service you provide to your customers. Botanical Dog will do our part, to help you provide quality customer service to your customers, by ensuring your order is received in a timely fashion. Customer support available 7 Days a Week 9am-7pm EST
9. Once you have completed all the required information to become a Botanical Dog IndependentSales Consultant will be issued a Consultant I.D and Login information for the wholesale division of our website.
10. These terms and guidelines have been set forth for the benefit of Botanical Dog IndependentPet Consultants, as well as Botanical Dog LLC. Failure to abide by these guidelines can result in termination of your Pet Consultancy. This Botanical Dog Pet Consultancy Agreement can be

terminated at any time by either you or Botanical Dog. In the event that you decided you no longer want to maintain your Pet Consultancy Status, please notify us so that we can remove you from our program.

11 Botanical Dog shall not be responsible for delays and failures in performance of its obligations when performance is made commercially impracticable due to circumstances beyond its reasonable control and the control of its suppliers, shippers, subcontractors and agents. This includes without limitation, strikes, labor difficulties, riot, war, death, severe weather, acts of god, curtailment of a party's source of supply, or government decrees or orders.

12 Botanical Dog makes every effort to ship within 2 days of processing an order. If an order is out of stock it will be sent as soon as our inventory is restocked. Back ordered items may be cancelled by the customer. Customers and Consultants have 14 Days in which to return merchandise for a full refund. They have 7 Days to make claims for damages or shortages occurring from shipping and handling.

13. Botanical Dog is not responsible for insurance for the individual Pet Consultant. Botanical Dog is nor responsible for any claims made against the Individual pet Product Consultant.

14. All advertising generated by the pet consultant must be approved by Botanical Dog.
